### Suggested Solder Pad Layout





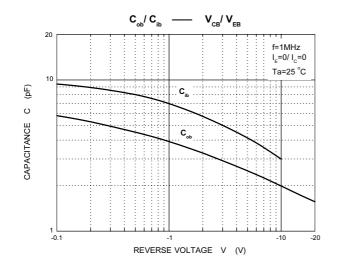

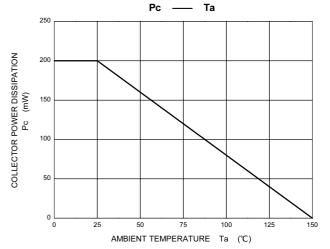
