


Figure 1. Static Characteristic




Figure 3. DC current Gain




Figure 5. Output Capacitance




Figure 2. Transfer Characteristic




Figure 4. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 6. Current Gain Bandwidth Product




Figure 7. 3-LEAD, TO-92, MOLDED 0.200 IN LINE SPACING LD FORM (J61Z OPTION)
