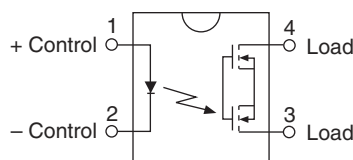

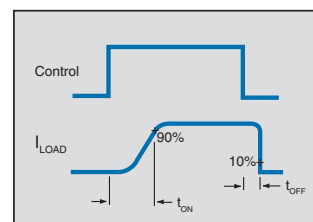

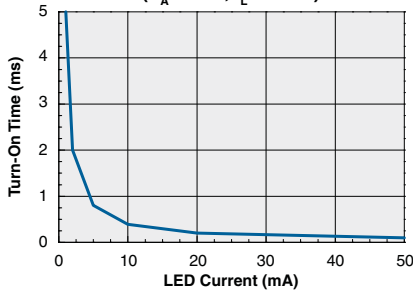

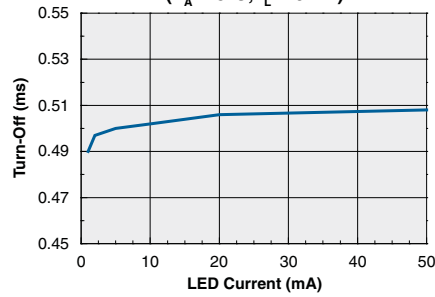

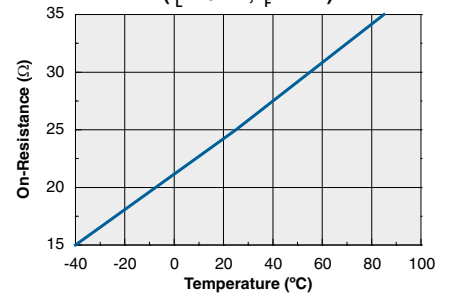
Typical Turn-On vs. LED Forward Current
($T_A=25^{\circ}\text{C}$, $I_L=70\text{mA}$)



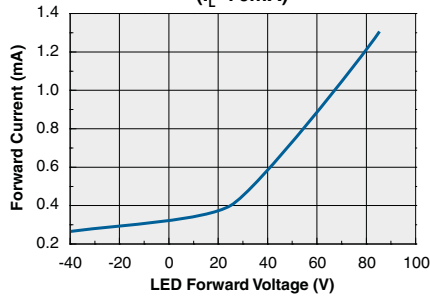
Typical Turn-Off vs. LED Forward Current
($T_A=25^{\circ}\text{C}$, $I_L=70\text{mA}$)



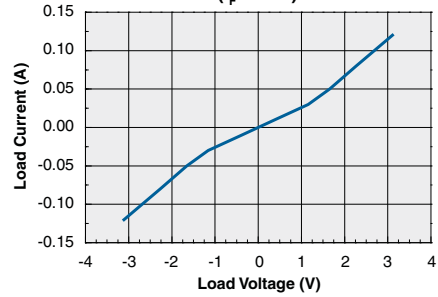
Typical On-Resistance vs. Temperature
($I_L=70\text{mA}$, $I_F=2\text{mA}$)



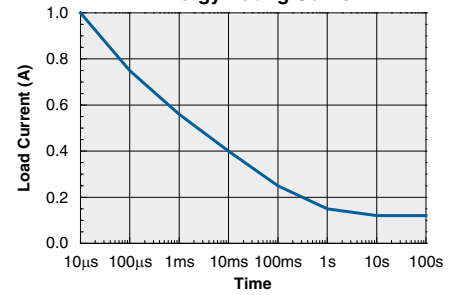
Typical I_F for Switch Operation vs. Temperature

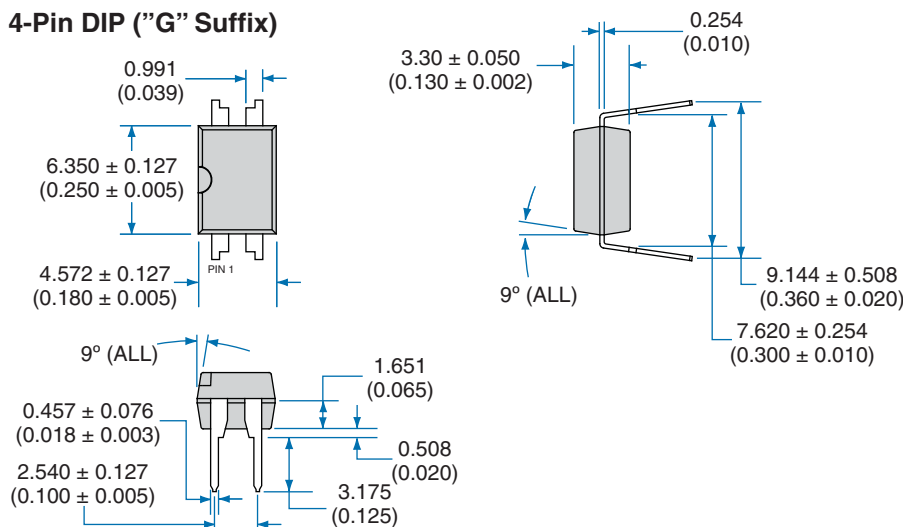
Washing

Clare does not recommend ultrasonic cleaning or the use of chlorinated solvents.

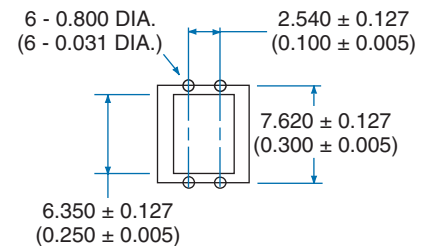

4-Pin DIP ("G" Suffix)

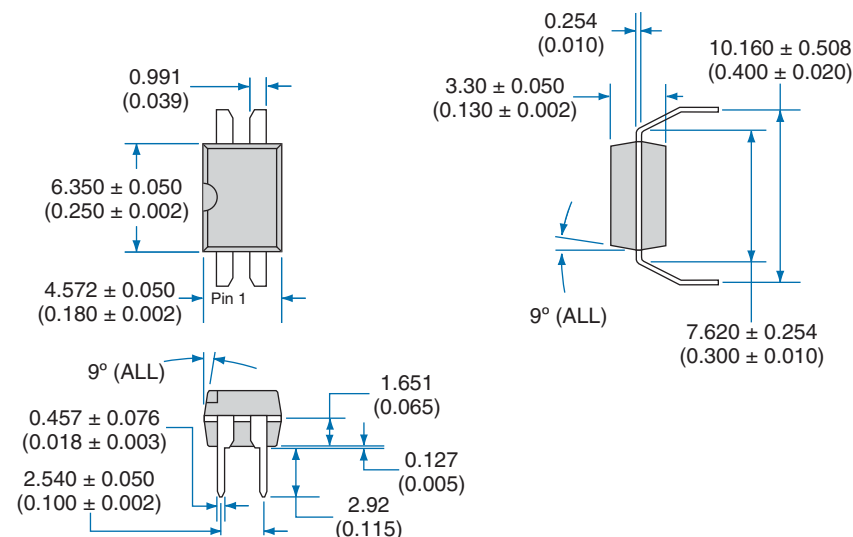


PC Board Pattern (Top View)

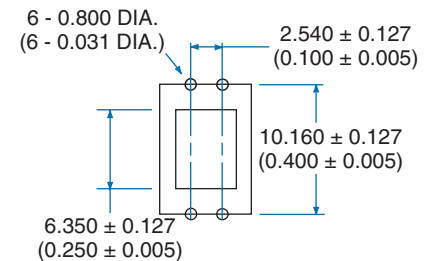

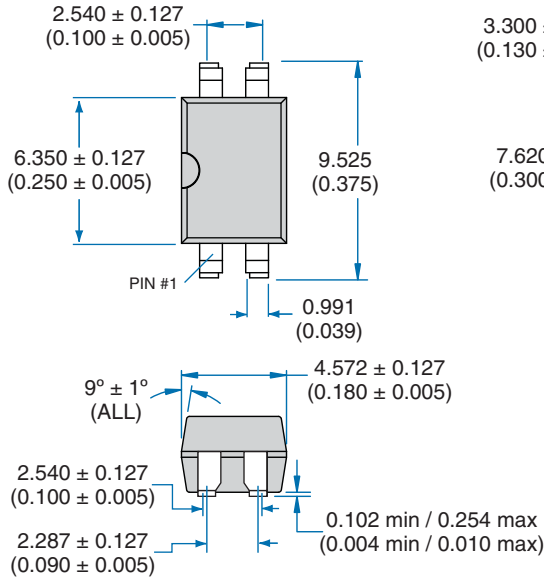
PC Board Pattern (Top View)



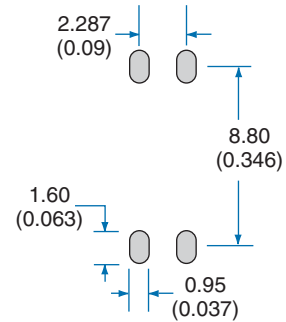

4-Pin Surface Mount ("GR" Suffix)

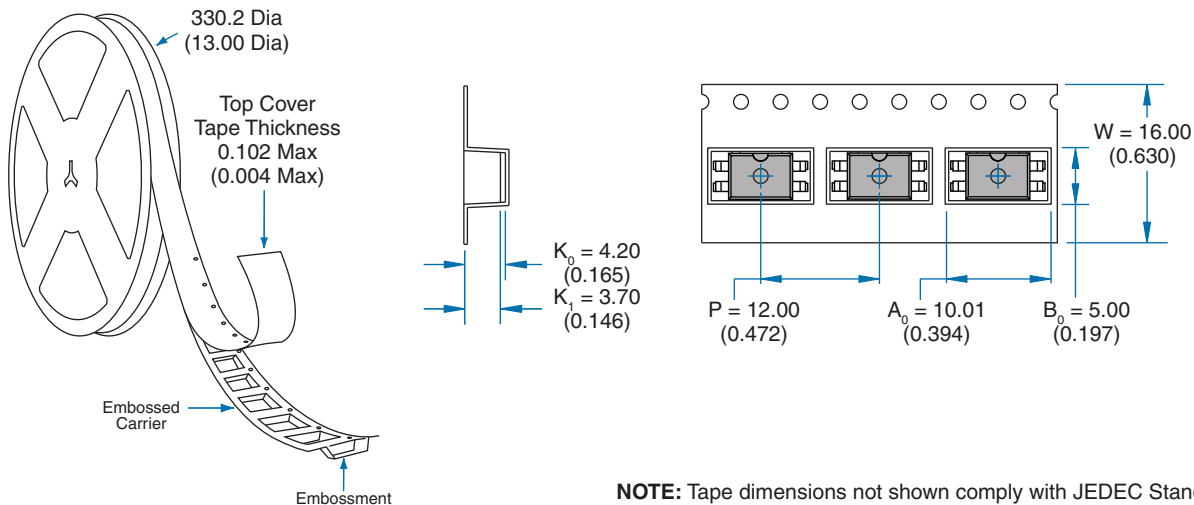


Recommended PCB Land Pattern
