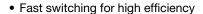

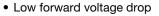

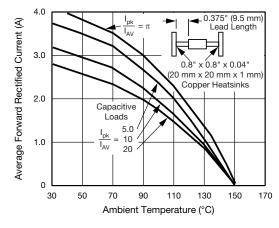


Fig. 1 - Forward Current Derating Curves

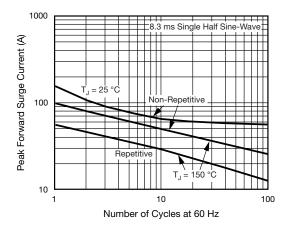


Fig. 2 - Maximum Peak Forward Surge Current

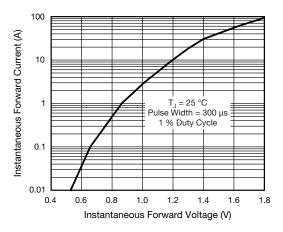


Fig. 3 - Typical Instantaneous Forward Characteristics

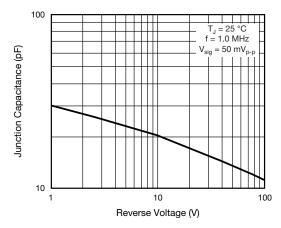


Fig. 5 - Typical Junction Capacitance

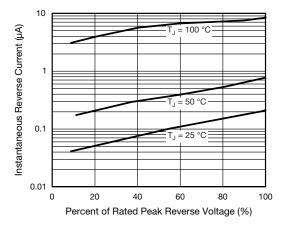
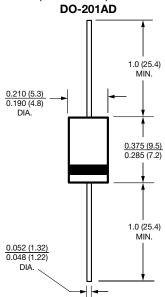


Fig. 4 - Typical Reverse Characteristics
